





National Central Bureau (NCB)


- Collects criminal intelligence and passes it on to other NCBs and the INTERPOL General Secretariat

- Receives requests for information, i.e. from other NCBs on behalf of their national authorities




C INTERPOL Wildlife Working Group

This group focuses the expertise and experience of law enforcement officers on poaching, trafficking, or possession of legally protected flora and fauna. It runs a number of projects including:


- Operation baba targeting illegal ivory sale in Africa

- Operation TRAM on traditional medicine


















