the graduate in the field of cultural studies, trainer, negotiator, human rights activist, also a graduate of the School of Human Rights at the Helsinki Foundation for Human Rights, co-founder and long-time President of the La Strada Foundation against Trafficking in Persons and Slavery (since 1995), for 28 years she has been organizing help for victims of human trafficking and fighting for their rights, she shares her knowledge at conferences and in the media and coordinates the National Intervention and Consultation Center for victims of human trafficking, since 1999 she has been conducting interactive, original training for professionals, she develops social campaigns, winner of the Ombudsman's Office award: Paweł Włodkowic Award, in 2022 she was honored by the U.S. Department of State with the American TIP Hero Award.
