SUMMARY

The aim of the training programme is to enhance the awareness of non-competition national enforcers (judiciary staff and law enforcement staff) regarding competition matters through training activities and study visits. These activities intend to improve the non-competition national enforcers' ability to identify potential anticompetitive behaviour by understanding what information and evidence would be valuable for enforcing EU competition law.

By increasing the knowledge of non-competition national enforcers and fostering investigative cooperation, this initiative aligns with the EU's strategic objective of strengthening the ex-officio enforcement carried out by the European Commission and National Competition Authorities (NCAs). This is achieved by involving more enforcers in detecting and prosecuting anticompetitive actions. The European Commission particularly seeks to reinforce the collaborative efforts with non- competition national enforcers, encouraging them to share information and evidence related to potential infringements of EU competition law with the European Commission and NCAs.

The information and evidence gathered by these enforcers during their routine investigation activities in economic and financial matters (non-competition related investigations and under criminal regimes) hold paramount importance for the ex- officio enforcement of EU competition rules. In the Exotic Fruit case, the European Court of Justice has also validated this form of enforcement cooperation, confirming the utilization as evidence by the European Commission's Directorate-General for Competition (DG COMP) of the information transmitted obtained by national non-competition enforcers.





Specific Objectives:

- **Objective 1:** Training addressing both management and operational personnel of the non-competition national enforcers (senior and middle managers of investigators as well as investigators).
- **Objective 2**: Training of personnel of the non-competition national enforcers managing or conducting investigative activities in economic and financial matters, under criminal regimes, as core daily tasks.
- **Objective 3**: Training of personnel of the non-competition national enforcers employed throughout the National territory of the Member State.
- **Objective 4**: Publication of internal guidelines for non-competition national enforcers.

OVERVIEW

8 training sessions in the judicial training schools of the EU Member States and 3 study visits at the Directorate General for Competition of the European Commission are foreseen in the framework of the programme. Below is an overview of the programme:

WORKING LANGUAGE:

The working language of all training sessions and study visits will be English.

EXCLUSION CRITERIA

The training sessions and study visits shall not be addressed to the personnel of the noncompetition national enforcers following induction courses (or initial training courses) at the time of joining the beneficiaries.

Each participant is allowed to attend not more than one training session. Additionally, they will not be allowed to attend study-visits if already attended the training session.

Other exclusion criteria:

- Prosecutor or judges not managing or conducting investigations in economic and financial matters, as core daily tasks
- Judges not managing investigations
- Trainees
- Junior management law enforcement personnel

REGISTRATION

Interested candidates are invited to apply through their national training institution. Once selected, they will receive an official invitation to the event including a link to register their participation on the EJTN platform.

REIMBURSEMENT
